The Missouri Alliance for Children, Youth, and Families

Sponsorship/Exhibitor Agreement

Liability: Neither the Missouri Alliance for Children, Youth and Families or their exhibit chairs, or the State of Missouri, will be responsible for any injuries, loss or damage that may arise to an exhibitor, employees, and/or goods either while in transit to or from the building, or while in the building, from any cause whatsoever, and will not be liable for the fulfillment as to delivery of space beyond the conference committee’s control.

Exhibitor agrees to hold MACYF blameless and to reimburse them for any judgments, settlements, cost or other expenses (including fees) to which they may be subject for any injury, damage, loss or harm resulting or occurring to anyone because of noise, method of operation, materials, or in general detract from the general character of the MACYF Advocacy Day or which compromise the safety or security of the building or patrons (including visitors) which may result directly from or in connection with such exhibits or the use of the rented space by the exhibitor, the employees, or the representatives.

Management Rights: Management reserves the right to restrict exhibits which are inconsistent with the mission of day.

Care of the Building and Equipment: Display area is limited to the assigned table and the walls may not be used for any displays or posters of any kind. Exhibitors or their representatives must not damage nor deface the walls of the building or the tables or equipment. If such damage occurs the exhibitor is liable to the owner of the property damaged.

Use of Space: All demonstrations or other promotional material or activities must be confined to the limits of the exhibit table area. (3’X 6’) Note: Exhibitors may not sell any items.

Security: The exhibitor is solely responsible for his/her own exhibit material and should insure against loss or damage. All property of the exhibitor is understood to remain in his/her care, custody, and control in transit to and from and within the confines of the exhibit area.
